- Contacted 51 I&E chiefs and agency-level members, requesting assistance in updating online directory. Have received responses from 41 and updated website accordingly. Still sending follow-up messages to non-responders.

Communications

- Next issue of The Balance Wheel to go out Sept. 15. The distribution list now has 531 subscribers (+60 since last report, mainly due to promotion at conference).
- Seeking remainder (1) of TBW articles from last year's scholarship recipients. Deadline for submissions from this year's scholarship recipients is Sept. 29. Several have already submitted theirs.
- As of Sept. 8, posted to ACI Facebook page 23 times since July meeting. Many postings from the conference site, plus a good number of job opportunity announcements. Facebook page has 455 likes (+25).
- Photos from 2017 conference posted to website. Primarily due to the conference and the posting of award winners, we had our best viewer day ever on July 17 – 359 unique views.

ITEM NO. 10: 2017 ACI Annual Conference (Indiana) and Auction Report.

- 1. Indiana received the customary \$5,000 advance from the ACI Treasury.
- Kentucky and South Carolina made direct payment of conference registration fees (\$3,975 total) for their attendees to Judy Stokes Weber. This should reduce Indiana's reimbursement of the \$5,000 advance to \$1,025. Note: Kentucky's payment (\$1,875) has been received by Judy, South Carolina's payment (\$2,100) is in the mail.
- 3. There is a current balance of \$8,821.39.
- 4. There are three unpaid receipts:
 - a. New Mexico, \$700 registration fees
 - b. Georgia, \$350 registration fee
 - c. J.F. Griffin Publishing, \$1,500 sponsorship
- 5. There is one unpaid invoice of \$332.50
- 6. The final bill from Abe Martin Lodge for meeting space rental is still being negotiated.

Bottom line, unless there are any undiscovered expenses lurking in the shadows, we anticipate sending the ACI Treasury a profit in the vicinity of \$10,000.

The final tally for the auction was \$5,008.90.
