ITEM NO. 3: Approval of Minutes.

Membership

Judy and I continue to work well together in coordinating the mechanics of the Membership Recruitment/Renewal process.

- Judy has sent invoices to all renewing and lapsed members. She is also adapting to the various processes that different agencies have in paying for memberships.
- She is alerting me to those members who haven't responded, and I am sending gentle reminders.
- Judy notifies me as renewals come in. I respond with a thank-you email that includes the new "Did You Know?" one-pager. We also use that opportunity to request directory updates and urge them to ask coworkers to subscribe to The Balance Wheel.
- I use the renewal information Judy provides to keep a spreadsheet of current members and their invoice contacts. I share that back with Judy weekly to ensure accuracy.

Communications

- I was blocked from accessing our own website (both admin side and public) for a week or so. Finally resolved via a service call from Comcast and a new modem.
- Next issue of *The Balance Wheel* will be published Tuesday, Nov. 15 and emailed to 568 subscribers. Articles will include, among other topics, Dan Dennison's video piece on Tennessee Wildcast, a recap of Sarah Southerland's Social Media session at the conference and a summary of how Nebraska used its R3 grant. Sadly, my request of members to share their most helpful feedback/critiques from contest judges received an underwhelming response (1).
- We had 9 scholarship recipients at this year's conference. All but one have submitted their articles.
