ITEM NO. 5: Treasurer's Report.

Presented Judy Stokes Weber, Treasurer.

• Judy Stokes Weber said "we are in good financial shape. I will provide a proposed budget to the next meeting and have it ready for approval at the conference."





ITEM NO. 6: Communications Report.

Presented by Scott Ball, Membership Communications Chair.

- Scott Ball said "we have more members than we have ever had that I can recall."
- "I had A.I. write something about the upcoming conference for the Balance Wheel, but then I decided to add the G.I. (genuine intelligence) version," Scott jokingly added.
- Ball said, "I sent Lance (Cherry) my notice of intention to resign and finish at the end of September. I am ready to be full-time retired. It's time for new blood and change is a good thing." • "I have been working with local manufacturers in Oregon, looking for donations," Tim Akimoff said. "I have also reached out to local photographers about donating prints etc."

ITEM NO. 9: 2023 ACI Conference update.

Presented by Aaron Meier, 2023 Conference Coordinator.

 Aaron Meier said "I have two conferences going on right now and I will be focusing 100% on ACI after next week." "I feel like Delaney isn't getting the sponsors yet," Meier added.

ITEM NO. 10: Futures Conference Report.

Presented by Kay Ellerhoff, Future Conference Hosts Chair.

- Kay Ellerhoff said "We have a little problem as our meeting in 2025 is with New Jersey. Linda (DiPiano) is finding out that beach front hotels are out of budget."
- Linda DiPiano responded "the best place (for the conference) would be Atlantic City as it's the cheapest and has the most hotels. July in New Jersey is the most expensive." DiPiano added, "the Resorts Casino and Hotel is a good prospect. The federal rate is \$98, but the cheapest I have found is \$158, so finding hotels is impossible. There is nothing inland in New Jersey that will do something under \$300 a night."
- Lance Cherry responded, "for most of the state agencies, we have cushion to pay more than the federal rate and scholarships can also help the federal folks who are attending."
- "If we are under \$150. I think that is doable" said Jenifer Wisniewski.

ITEM NO. 11: Awards Report.

Presented by Beth Quillan, Awards Co-Chair.

- There were 598 entries this year.
- Beth Quillan said "we are well into the judging round and that closes on May 22nd. Many judges have started, but there are still a lot that haven't."

Joanne Martonik said "the scholarship application has been out for about five weeks now and we have 14
people who have applied."
