## **Approval of the Minutes:**

### **Treasurer Job Description Discussion:**

Micah Holmes led the discussion on what the ACI Board needs to do to replace Chuck Schlueter as the treasurer. He outlines three main points

- A. decide on the description
- B. decide on the timeline to announce the position
  - a. Micah Holmes and Don King with finalize the draft position description.
  - b. The final description will be sent to the Jeff Eschler (ACI's web designer) to be posted by 08/12/13.
  - c. The job will remain open until 08/26/13.
  - d. Depending on the number of applicants, a selection/interview committee will be created by Don King to select the new treasurer.
  - e. The preferred/selected applicant will be discussed at the next ACI Board meeting.
  - f. The successful applicant will be appointed by Don King and there will be a formal membership vote at the next annual conference (Nebraska 2014).
- C. decide to pay for room and board up to \$1500 for treasurer to attend annual conference
- D. decide whether or not to make the position paid

**Motion:** Micah Holmes made the following motion . . . The treasurer's travel and accommodations shall be reimbursed for attendance at the annual conference up to \$1,500. A stipend in the amount \$1,000 will be paid each year that the membership count meets or exceeds 50 on June 30. In the first year of the Treasurer's term a \$500 stipend may be provided to the Treasurer to cover transition costs.
