One item for your consideration. I recommend that we close-out our NH ACI account. We had kept this open to help out some states that had direct deposit set-up there. We have transitioned most of them and the one left I will work with over the coming months to change our listing in their accounting system No small task but we can get it done.

ITEM NO. 7: 2020 ACI Conference Update.

Presented by Lance Cherry, Vice President

Lance reported New Mexico restrictions are not expected to ease until September. Should ACI consider moving to a virtual conference?

Aaron said that state travel restrictions are extremely limited. Some states have restrictions until the end of March. Many cannot make arrangements to go in time, and the state approval process is difficult in short time periods.

Judy reminded the Board there are some upsides to online conferences. The online AFWA meeting was rich – new people and lots of quality discussion. Others agree there is lots of value and opportunity still.

Kay said in the past months she attended two virtual mass funerals. They went smoothly, and there was a strong sense of community still.

Following discussion, the Board determined the overall feedback is that we need to move to a virtual conference for 2021.

If we go online, we could reduce the costs, and potentially offer more opportunities for scholarships. Sara recommended offering more scholarships to allow more people from a single agency to attend on a scholarship.

Judy suggested the same scholarship budget could go further online. ACI usually spend about \$10,000-\$15,000 on scholarships each year. We are in a very good financial place with ACI, and could offer very low attendee fee. The scholarship could cover quite a few people to attend. The rate for other similar conferences is \$100-125, but there is potential to go lower with our flush account.

Lance was encouraged that we can still bring all the elements from ACI online.

Jenifer recommended bringing a great keynote and investing in some good speakers.

Jason asked if the registration would pay for the platform we use. Lance said yes, it would be used to cover the platform.





The online conference dates will be the same as planned.
