## Presented by Lance Cherry, Vice President

The board was asked to consider how to proceed with the 2020 ACI conference. Due to impacts from COVID-19, the likelihood of hosting an in-person conference is slim. Lance expressed a desire to be responsible with ACI funds and make decisions about how to proceed – whether that be online, delayed or cancelled entirely.

Kyle Martens raised the concern of limited out-of-state travel. He supported online awards, but not trying to mimic a full conference online.

Kay Ellerhoff said that Delaney has recent experience helping to host an online conference and maybe could help if we went that direction. Kay also raised concerns about jostling the state conference host years, as some states are locked-in for certain years. TN volunteered to fill any vacancies, if needed.

Blake Podhajsky and Tim Akimoff both raised concerns about how to execute of a virtual conference effectively, and said it would be shame to skip the NM location and toss out the work of the NM staff.

The board discussed how to tackle the business meeting – including new members to the board and new officers. How to recruit new board members was also discussed. No one from NC, PA, MI, NJ, don't have anyone on the board so those states could be recruited. Jenifer will review the bylaws and report what guidance they provide for next steps, following recommendation from Kim Nix.

Blake is in favor of having the business meeting and going through the process as much as possible because that can happen virtually.

The ACI spirit award was discussed with the possibility of skipping a year.

Blake provided an overview of the awards and the board discussed the possibility of hosting a 2020 awards ceremony online rather than a hold-over until next year. Thus far, entries are down. We are going to make some money, but not as much as usual. Judy said there wouldn't be a revenue issue related to moving awards online this year, as long as award revenue and dues remain relatively strong.

Lance will continue to seek sponsors and we can still conduct a raffle.

Lance – he proposed July 2021 for New Mexico, with hosting the virtual awards and a keynote. Kay will work with upcoming states to rework conference years

**MOTION:** Jenifer Wisniewski moved to delay the conference in New Mexico until to 2021 and host the 2020 awards virtually. virtual awards. Jason Harmon seconded the motion.
